

'Come Cruise with Me' Terms and Conditions

Conditions of Entry

1. Information on how to enter and prizes forms part of these Conditions of Entry. Entry into the Curves South East Queensland Co-op 'Come Cruise with Me' Promotion is deemed to be an acceptance of these Conditions of Entry.
2. Promotion commences Monday 4 July 2011 at 5.00am AEST and entries close at 8:00pm AEST on Sunday 11 September 2011 (Promotion Period).
3. Entry is only open to members **18 years and over** of the following Curves Fitness for Women Centres in Queensland: Atherton, Beerwah, Brassall, Bribie Island, Kawana Waters, Caloundra / Currimundi, Capalaba, Carina / Carindale, Cleveland, Dalby, Eight Miles Plains / Sunnybank, Ferny Grove (Keperra), Forest Lake, Gatton, Gladstone, Gympie, Hervey Bay, Indooroopilly, Ipswich South (Yamanto), Kenmore, Kingaroy, Daisy Hill/Shailer Park, Lutwyche, Manly / Wynnum, Maroochydore, Mareeba, Mitchelton, Morningside / Bulimba, Mt Gravatt, Mt Ommaney, Noosa Heads, Nundah, Palm Beach / West Burleigh, Redbank Plains, Rockhampton, Sandgate, Toowoomba North, Toowoomba South, Victoria Point, Warwick (participating Curves Fitness for Women Centres).
4. Curves South East Queensland Co-op Membership fees must be current at the commencement of the 'Come Cruise with Me' promotion and at the date of draw.
5. Employees (and their immediate families) of the Promoter, agencies or companies associated with the conduct of this Promotion (including Curves Franchisees and their directors, employees and immediate family members) are ineligible to enter.
6. For a chance to win:
 - A. Work out at a participating Curves Fitness for Women Centre at least 3 times in one calendar week (Workout Entry) during the Promotion Period. You will then be provided with (or must collect) 3 entry forms from the participating Curves Fitness for Women Centre. You must complete all details on these forms and return it to the participating Curves Fitness for Women Centre prior to the conclusion of the Promotion Period.
 - B. If you are not currently a member of any Curves Fitness for Women Centre, become a member of the participating Curves Fitness for Women Centre (on a minimum 12-month direct debit program). You will then be provided with (or must collect) 10 entry forms from the participating Curves Fitness for Women Centre. You must complete all details on these forms and return it to the participating Curves Fitness for Women Centre prior to the conclusion of the Promotion Period.
 - i. Not be or have not previously been a member of any Curves Fitness for Women Centre;
 - ii. Sign onto a 12-month direct debit program at the participating Curves Fitness for Women Centre;
 - iii. Be a member of a participating Curves Fitness for Women Centre at the time of the draw;
 - iv. Workout at a participating Curves Fitness for Women Centre at least 3 times in 1 calendar week (Workout Entry) during the Promotion Period. You will then be

provided with (or must collect) 3 entry forms from the participating Curves Fitness for Women Centre. You must complete all details on these forms and return it to the participating Curves Fitness for Women Centre prior to the conclusion of the Promotion Period.

- C. Refer a friend to join a participating Curves Fitness for Women Centre. The friend must:
- i. Not be or have not previously been a member of any Curves Fitness for Women Centre;
 - ii. Sign onto a 12-month direct debit program at the participating Curves Fitness for Women Centre;
 - iii. Be a member of a participating Curves Fitness for Women Centre at the time of the draw;
 - iv. Mention the name of the referring member at the time of becoming a member (only 1 member can be stated as the referrer (Referral Entry)). You will then be provided with (or must collect) 10 entry forms from the participating Curves Fitness for Women Centre. You must complete all details on these forms and return it to the participating Curves Fitness for Women Centre prior to the conclusion of the Promotion Period; and
 - v. Workout at a participating Curves Fitness for Women Centre at least 3 times in 1 calendar week (Workout Entry) during the Promotion Period. You will then be provided with (or must collect) 3 entry forms from the participating Curves Fitness for Women Centre. You must complete all details on these forms and return it to the participating Curves Fitness for Women Centre prior to the conclusion of the Promotion Period.
7. Each event set out in Clause 6(A) qualifies a member for 3 entries into a draw. A Referral Entry (Clause 6(C)) will result in 10 entries for the referring member, and 10 entries for the new member, provided that the requirements set out in Clause 6(C) have been met. A new member entry will result in 10 entries for the new member provided the requirements set out in (Clause 6(B)) have been met. 8. Entries are deemed to be received at the time of receipt by a participating Curves Fitness for Women Centre. Records of participating Curves Fitness for Women Centres are final and conclusive as to time of receipt.

10. Minor "Club" prizes will be drawn first prior to the major prizes being drawn. The first valid entry from each club will win 1 (one) months membership. "Club" level prizes consist of up to \$70 monthly membership paid for the winning member of each participating club. Prize is not transferable and not redeemable for cash. The winner must be an active adult (18 years and

over) member who is financial during and after the promotion. The winning member, if on a direct debit setup, will receive their monthly membership paid up to \$59.  - b) Accommodation is for 2 adults in an oceanview twin stateroom
 - c) Valued at *\$5,018 per adult this fare includes taxes and charges
 - d) The prize does not include any connecting domestic air or transfers which the prize winner may require to connect with ship
 - e) The prize is not transferable nor is it redeemable for cash
 - f) All accommodation, entertainment and most activities and facilities are included
 - g) Spending money, drinks, meals in alternate restaurants, tips, snacks and items of a personal nature are not included
 - h) Valid Passport is required
 - i) The conditions of booking a P&O Cruise are as per the terms and conditions in the P&O cruise brochure
 - j) Once booked, changes are not permitted
 - k) Prize is subject to availability onboard P&O vessels departing from Australian ports at time of booking. It is advisable to book early to avoid disappointment
 - l) Travel must be completed by 30 October 2012
 - m) Cruise Prize departure must be decided and booked by 11th November 2011

Coles/Myer gift cards are transferable and can be used at Coles supermarkets, Bi-Lo, Target, Baby Target, Target Country, Kmart, Kmart Tyre & Auto Service, Liquorland, Coles Central and Pick'n'Pay. Full terms of use are available at giftcards.com.au or by phoning 1300 304 990. Coles/Myer gift cards will expire 2 years from date of issue and are issued by Coles Group Limited.

16. The winners will be notified by mail and by telephone and the winner's name will be published in The Courier Mail on 22nd October 2011. Winners' names will also be published on the Curves website at www.curvesqueensland.com.
17. The Promoter may conduct such further draws at Level 2, 182 Bay Terrace, Wynnum, Qld 4178 as are necessary on 21st January 2012 for an unclaimed prize subject, however, to any directions given by any applicable gaming authorities. The winners of any unclaimed prize will be notified by mail and by telephone and their details published in The Courier Mail on 28th January 2012.

20. The Promoter and its associated agencies or companies accept no responsibility for lost, late, stolen, damaged or misdirected entries, irrespective of the cause.

For any reason this Promotion is not capable of running as planned, the Promoter reserves the right in its discretion to modify the terms of the Promotion, including the prizes and these Conditions of Entry, subject to approval of the gaming authorities in each State and Territory where relevant.
22. Any tax liability arising as a result of accepting any prize is the responsibility of the winner.
